Subject: Extending E1 + 5 increments to all the JTOs/JAOs recruited on provisional E1 scale.

Respected Sir,

We have been visiting various SSAs for increasing awareness on current financial condition of BSNL and role of AIGETOA in revival of BSNL as well as for membership drive to increase the membership of AIGETOA Gujarat.

Sir, one common point which has been raised by many BRs during interaction with them is the non-finalization of their pay scale post second pay revision. We know that consequent upon 2nd pay revision, the pay scales in BSNL were revised expect for E1A and E2A, the settlement of which is still pending even after more than 10 years.

It is pertinent to mention here that they are eligible for revised E1A, but because of non-finalization of revised E1A/E2A post 2nd pay revision, many JAOs / JTOs whether recruited directly or through LICE have been placed in E1 scale provisionally and their basic has been fixed at the minimum of the E1 scale.


Their contention is that if there had been an approved revised E1A scale, than their basic would have been fixed somewhat on higher side. But as they have been fixed at the starting basic of E1, their salary is reduced and they are facing financial loss because of non-settlement of pay scales.

Sir, we all know that BSNL, in past, has extended additional 5 increments to compensate loss to all those JAOs/ JTOs who were recruited post 2nd pay revision but in the pre-revised pay scale of E1A. Accordingly, the JTOs / JAOs recruited thereafter in provisional scale of E1 are also eligible for 5 increments till the new scale of E1A is not finalized.

Sir, in this regard, I humbly request you to kindly take up this matter with BSNL management by writing a letter and pursuing with top authorities for additional 5 increments on E1 scale till the finalization new pay scales for all the JAOs / JTOs who are recruited post 2nd pay revision and who are placed in provisional E1 scale. This will help to reduce their financial loss.

Sir, further inputs and other supporting documents shall be provided to CHQ as and when asked for preparing a strong case.
