## Manner in which election will be conducted:-

➢ As per the earlier notification dated 20.01.2024, nominations were called for all the 11 posts of Circle Executive Committee.

After completing the due process, the nominations were finalized by Returning Officer, Shri U R Chourasiya, AGM FTTH, Circle office on 17.02.2024 and were displayed on website aigetoaguj.org.

➢ On the spot nominations shall be called from amongst the present members during the AGM for only those posts for which no nominations have been received.

Sequence of election for the posts will be decided by the Returning Officer. Voting will be done only by members of circle collegium who remain present in the house. No proxy voting is allowed.

Circle collegium is already finalized by Returning Officer on 17.01.2024 and list of members of circle collegium is available on Gujarat AIGETOA website.

Solution As discussed in CEC meeting, Returning Officer may appoint one ARO (Asst. Returning Officer) to assist him during the whole election process. Methodology for voting will be decided by RO.

In the event of any dispute or objection regarding election, the decision of Returning Officer shall be final and binding to all.
